RIVERSIDE CITY COUNCIL MEETING; February 21, 2017

The Riverside City Council meeting opened at 6:32 pm in City Hall with Mayor Pro-Tem Ralph Schnoebelen requesting roll call. Council members present were: Rob Weber, Bob Schneider Jr., Tom Sexton, and Jeanine Redlinger.

Schneider moved to approve agenda. Second by Redlinger, passed 5-0.

Schneider moved to approve 2/06/17 minutes. Second by Weber, passed 5-0.

Motion by Schneider to omit two MMS bills from expenditures for more details. Second by Weber, passed 5-0.

Sexton moved to pay remaining expenditures. Second by Redlinger, passed 5-0.

Citizens Comments; Andy Rodgers, Rene Arps, and Kathy Lindhorst asked the Council about the removal of the Barn Quilt from the Museum. Council requested that they return to a future meeting with placement suggestions.

Sexton moved to table the decision to hire a Realtor for Cherry Lane. Second by Redlinger, passed 5-0.

Jeff Huber of Greiner Buildings answered Council questions on the park shelter design concept. Schneider moved to approve Greiner Buildings for a concept design at a cost of \$2500. Second by Redlinger, passed 5-0.

Bill Stuke, PeopleService, Inc. presented monthly Water and Wastewater reports. Ferguson will start new meter installation on 2-27-17.

Building Permit Fees were discussed. Resolution #022117-01 was tabled. Jay Skuelke and Chad Sands will be asked to attend the March 20th Council Meeting.

Several options were presented for Property Tax Rebates on a New Business. Incentives would be paid with Casino Funds. Weber moved to rebate 100% with a 10% reduction each year for 10 years. No second was made. Schneider moved to rebate 100% for three years, then 10% reduction each year for six years total. Second by Weber, passed 5-0.

Redlinger moved to approve quote of repairs to the Community Building from Smock Companies for \$1135.44, with RACC providing labor. Second by Schneider, passed 5-0.

Weber moved to table Resolution # 022117-02 Truck Purchase. Second by Schneider, passed 5-0.

Weber moved to pass Resolution #022117-03 Law Enforcement Contract FY 17-18 with Washington County for \$ 53,089.00. Second by Sexton, passed 5-0.

Council held discussion on the status of the Sr. Dining meal program. Redlinger is checking into other options.

Council Comments; Schneider asked about 2016 City wages. They were published in the 2-16-17 paper. Redlinger read a statement of opposition to the State Bill that just passed on Healthcare Insurance for State Employees. Sexton requested that the Council address conditions of "City Right of Way" on all City ditches in the near future. Weber issued "thank-you" to city staff for the additional budget information and meetings, Bill Stukey for water reports, RACC for concern of Barn Quilt, and Kalona News for the enhanced Riverside coverage in the paper. Schnoebelen added his thanks to City Staff for all the time put into budget preparations.

Sexton moved to adjourn at 9:15 pm. Second by Redlinger, passed 5-0.

RIVERSIDE CITY COUNCIL MEETING; February 27, 2017

The Riverside City Council Special meeting opened at 6:05 pm in City Hall with Mayor Allen Schneider requesting roll call. Council members present were: Bob Schneider Jr., Tom Sexton, Jeanine Redlinger, and Ralph Schnoebelen. Rob Weber was absent.

* Motion by Sexton to approve agenda, moving item #3 and #6 to the top. Second by Redlinger, passed 4-0.

Schneider moved to approve Resolution #022717-01 Set date for Public Hearing on Washburn & 2nd Street for March 13, 2017 at 6:15 pm. Second by Sexton, passed 4-0.

Schneider moved to pass Resolution # 022717-02 Set the date for Public Hearing on FY 2017-18 Budget. Second by Schnoebelen, passed 4-0.

Weber arrived at 6:21 pm.

John Sojka returned to council in reference to property tax rebates. Schneider moved to rescind motion of February 21st to rebate 100% of tax for three years, then 10% reduction for the next three years. Second by Sexton, passed 5-0. Sexton moved to rebate 100% of taxes for up to six years, with the total rebate amount not to exceed \$80,000. The agreement would require Mr. Sojka to submit his paid tax receipt to receive the refund, and would not be transferable to any future owner. Passed 4-1, Schnoebelen opposed.

MMS addressed council on the Washburn & 2nd Street project. Stacy-Lewis Funeral Home has agreed to 50% of cost share in angle parking on the east side of Greene Street in front of Sordon's. Project bids will be accepted until March 30th, with bid awarded on April 3, 2017.

Jeff Huber of Greiner Buildings, asked and answered questions referring to Hall Park shelter.


City Clerk Young reviewed the final FY 2017-18 Budget with Council.

Schnoebelen moved to adjourn at 9:43 pm. Second by Redlinger, passed 5-0.

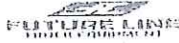

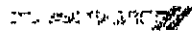
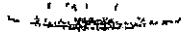

Good Morning Everyone:

I will not be attending the Riverside City Council meeting on Monday, March 6, 2017, so I thought I would write an update on a few items that are important to the City of Riverside. Below are some items that will be of interest:

1. Sidewalk for Diane and Alan Lowe at 205 Schnoebelen Street. A picture is attached of one sidewalk panel that has settled. Lowes claim that the sidewalk panel was removed and replaced during a recent project by the City of Riverside. This is a similar problem that occurred at Ron Popham's property a few houses south. It is clear that this panel was removed and replaced by the color of the concrete. It is my opinion that a service line was installed to the house and the trench was not properly backfilled. My recommendation would be to fix it if we had some other concrete happening in Riverside.
2. Bob Crawford contacted Lory Young about his semi-tractor being parked on Second Street. He did not want to lose his parking area. I met with him on March 2, 2017. Mr. Crawford has a driveway to his existing garage. I told him that we are not proposing to remove the gravel parking for the semi-tractor since he has the existing drive to access the gravel parking space. I said I would confirm my statement to him that we would not remove the gravel parking unless the city Council said that it should be removed.
3. I have contacted the Post Office in Kalona for additional or the correct information for mailbox location adjacent to paved street with curb and gutter. I am waiting for the response. I have included two pictures of the mail boxes on Ella Street. The contractor has assured me that the mail boxes will be moved if necessary. Keep in mind that the information obtained by our contractor came from the Riverside Post Office.
4. Lastly, I listened to your discussion regarding the shelter house at Hall Park last Monday night. I thought it would make sense to price the building with two different sizes. One size 100' x 50' and the other 60' x 50'. These prices then would give us a high and low budget number. Lory then could apply for a grant for the larger building. Should we receive the grant then move forward. If we don't get the grant, then scale back the project and build the size that would be appropriate at that time. Thank you for allowing me to make this suggestion.
