The Riverside City Council meeting opened at 6:01 pm in City Hall with Mayor Allen Schneider requesting roll call. Council members present were: Bob Schneider Jr., Tom Sexton, Rob Weber, Jeanine Redlinger, and Andy Rodgers.

Motion by Sexton to approve the agenda, Second by Redlinger, passed 5-0.

Council received Hotel/Motel grants presentations for FY 18-19

Mike Meinders and Mary Jane Stumpf reported on activities at the History Center.

Redlinger moved to approve the History Center grant in the amount of \$20,000. Second by Sexton, passed 5-0.

Amy Schulte, Washington YMCA, answered Council's questions on the Camp Highland Summer Program. The Y has purchased a 15 passenger van to transport children.

Redlinger motioned to approved granting the YMCA \$10,000, with 50% to be used for scholarships of Riverside Residents. Second by Rodgers, passed 5-0.

RACC representative, Kevin Meller addressed Council with plans for free summer activities in Hall Park.

Sexton moved to approve Fireworks Grant for March 2019 in the amount of \$7000. Second by Weber, passed 5-0.

Schneider moved to approve TrekFest XXXVI grant of \$18,800. Second by Weber, passed 5-0.

Sexton moved to approve Summer Concerts grant for \$5,000. Second by Weber, passed 5-0.

Rodgers moved to approve Summer Movie Series for \$5,000. Second by Weber, passed 5-0.

Redlinger moved to approve Paws & More \$2,500 Grant. Second by Weber, passed 5-0.

MMS Consultants, Glen Meisner and Ben Mitchel were present to discuss Galileo street width, and on- street parking. They will bring more options and cost estimates to the next meeting.

MMS has contacted Mary Rump, and Iowa DOT on possible route change for the Safe Route to Schools path. This will be on the next agenda for further discussion and possible action.

Weber moved to enter into Closed Session pursuant to Iowa Code Section 21.5(1)(i) Personnel at 7:35 pm. Second by Sexton, Passed 5-0.

Sexton moved to return to Open Session at 8:21 pm. Second by Redlinger, passed 5-0.

Redlinger moved to adjourn at 8:30 pm. Second by Sexton, passed 5-0.
