RIVERSIDE CITY COUNCIL MEETING: November 19, 2018

Work session at 6:00 pm for St. Mary's Street and HWY 22 project.

The Riverside City Council meeting opened at 6:35 pm in City Hall with Mayor Allen Schneider requesting roll call. Council members present were: Tom Sexton, Bob Schneider Jr., and Andy Rodgers. Jeanine Redlinger, and Ralph Schnoebelen were absent.

Motion by Sexton to approve the agenda, Second by Rodgers, passed 3-0.

Sexton moved to approve the minutes of November 5th, and expenditures. Second by Schneider, passed 3-0.

Council received Fire department October update.

Phil Richman addressed Council on mail delivery during street projects.

Jennifer Mize, Riverside Soccer applied for Hotel/Motel grant funding. She will work on getting Federal non-profit status, and insurance quotes.

Kelly Wood asked Council for parking assistance at 1182 Commercial Drive.

Sexton moved to pass Resolution 111918-01; Easement Agreement with Ellen Hall. Second by Schneider, passed 3-0.

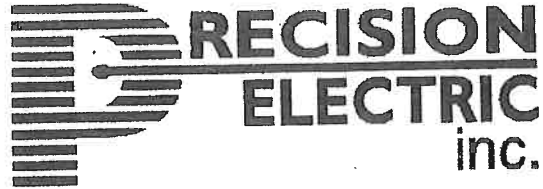

- We propose to furnish labor replace (83) 2x4 lay in fluorescent light fixtures with LED flat panel fixtures (supplied by others)
- We will remove existing fixtures and install new LEDs. All old fixtures and lamps will be left in rooms where they are removed and disposed of by others

Price: \$2,490

- Replace (7) T-5 fluorescent fixtures and (16) high bay fixtures in truck bay

Price: \$1,425

- Convert (5) 8-foot fluorescent strips to LED

Price: \$150

- Convert (8) stairwell fixtures to LED

Price: \$200

- Convert (10) 4-foot fluorescent strips to LED

Price: \$250

Update Riverside Fire Department Lights to New LED Technology

Create a safer environment with better lighting

TARGET: SAVE ENERGY, REDUCE MAINTENANCE, AND INCREASE LIGHTING

- LED technology does not give off U/V light so less bugs will be attracted to the fixtures
- Increased lighting will make daily tasks easier

With budgets generally tight, these entities have all been grateful to find a way to save money while updating their lighting.

The installation will be done at the discretion of the Riverside Fire Department. Payment will be due when the products are delivered.

SUBJECT: Placement of fill material and channel changes in a Flood Plain -
FODB Complaint # 26218

Dear Honorable Mayor and City Council:

This office received a complaint on October 10, 2018 alleging the City of Riverside and their contractors are hauling and placing fill material and creating very large pile of dirt in Hall Park within the floodplain of the English River. On October 10, 2018 I investigated the complaint. I met with Riverside City Clerk - Becky LaRouche, and discussed the complaint issue. Ms. LaRouche provided me a letter dated October 2, 2017 from the US Army Corp of Engineers (USACE) regarding the same issue the complaint was regarding.

The USACE letter states that your soil stockpiling project does not require a Section 404 permit, but the letter does go on to state that you must still acquire other applicable Federal, State and Local permits, if necessary. Therefore, based upon the fact that Hall Park has flooded several times within 2018, the City of Riverside must obtain a NPDES General Permit #2 for Construction activity stormwater controls or begin to remove the stockpile to an area that does not flood or cause potential to runoff into a drainage area or cause water quality issues.

The obtaining and adhering of the NPDES General Permit for Stormwater would require runoff controls along with implying the use of best management practices associated with protecting and stabilizing the soil stockpile until the City decides to utilize the soil for some other intended use.

Based upon the evaluation of your construction activities, this office is requiring you institute remedial actions to eliminate the conditions that are causing or could reasonably be expected to cause further pollution to the waters of the state. Therefore, you must comply with the following requirements **immediately**.

1. Obtain coverage under an NPDES storm water permit and comply with all conditions of the permit. In addition, submit to this office a copy of the pollution prevention plan developed for this soil stockpiling project. And, immediately install erosion controls in order to retain sediment at the site.

OR

2. Submit a written plan with a proposed timeline of your efforts to eliminate the current soil stockpile to a secured location that would prevent potential runoff discharges to waters of the state.
