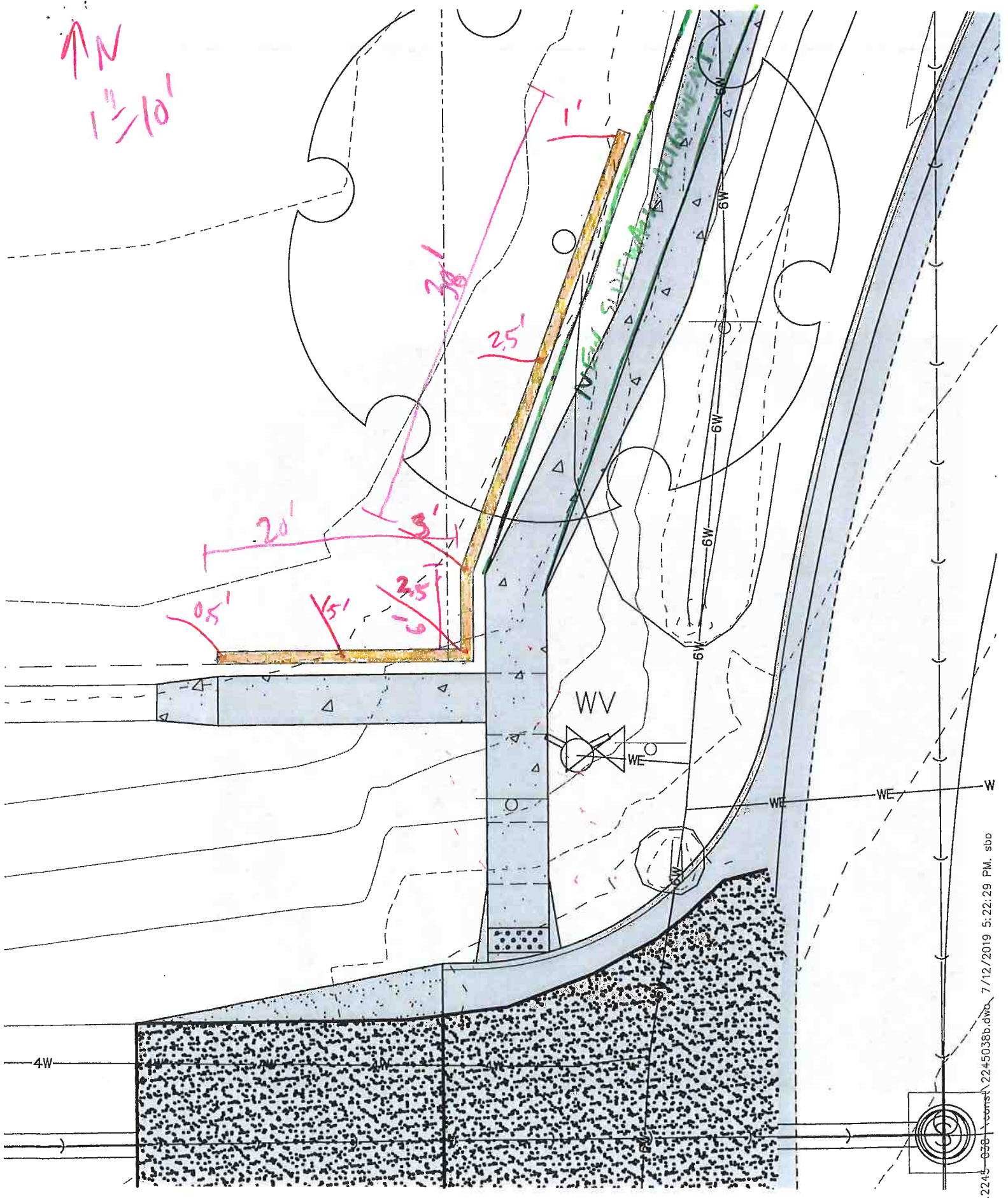

The plans showed grading on to adjacent property in order to make the ADA sidewalks work at the NW corner of Highway 22 and 4th Street. In talking to the adjacent property owner he asked if the City could build a retaining wall instead. The reason is that he has had vehicles leave the roadway through the curve in the past and end up in his yard and home. He felt the slope up from the sidewalk almost was like a ramp if a vehicle did leave the roadway again and that a wall may help protect his home if that happened.

Attached is a preliminary design of a wall at this location. The City Council is OK with a wall at this location. I wanted to reach out to you to make sure the DOT was OK with a wall at this location. A portion of the wall would be within the ROW so I assume would require permission from the DOT.

Please review the attached and let me know if this would be OK. Let me know if you need additional information.

Scott,

The DOT doesn't need to be involved with the patch locations or the materials for the asphalt or patching on this project. The agreement does include some provisions related to the construction responsibilities under Section 6. The DOT may assist if requested and the city will be billed for any testing services the DOT performs.

Please keep us posted on the progress of this project and let us know if there are other specific issues or questions as the project moves forward.

The contractor is to begin milling on Highway 22 on Monday. From there we will mark patches on Wednesday. Concrete patching and curb and gutter work will begin the week of July 8. It is anticipated that asphalt work will begin around August 1st.

I wanted to reach out to see if the DOT intended to be involved in any of that, either helping determine patching locations or for materials for patching or asphalt. I also wanted to make sure we are providing the testing and inspections required in order to provide you with the proper documentation at the end of the project.

Up until now the majority of the work has either been underground or not within the Highway ROW but starting next week the major parts of work within the Highway ROW will be beginning and I want to let you know and to make sure we are able to provide you with documentation you need for this work.

Please let me know if you need to have materials or other staff for this work. Also what we need to make sure we provide you if your staff will not be involved very much.

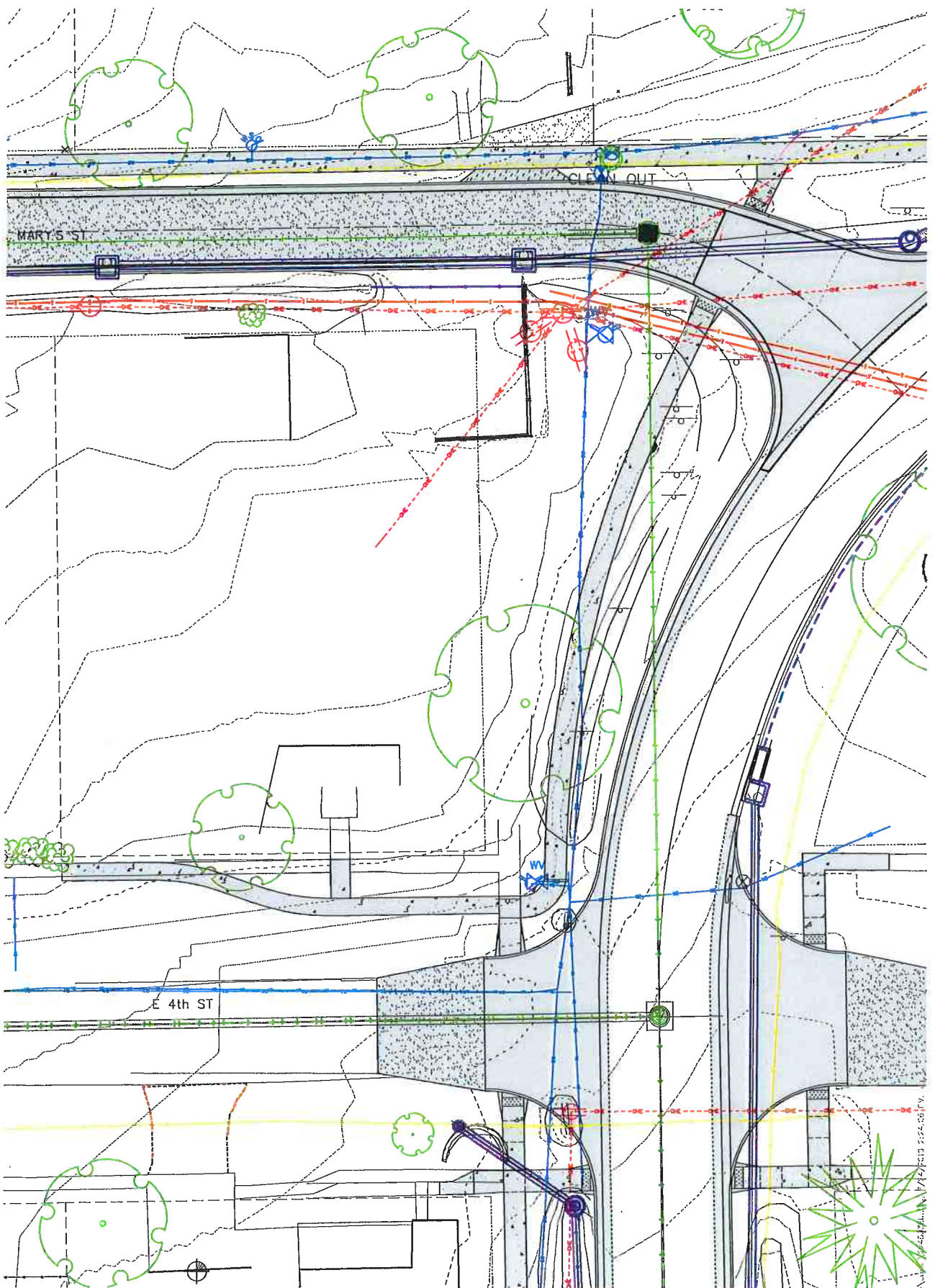

So if it could stay on the original alignment on Hwy 22 and then go farther down in the ROW on 4th they were good with that. You would just move the 4th Ave side down closer to the street as you were concerned about the steep slope from Hwy 22 going west correct? Otherwise it could just stay with the original alignment then there wouldn't be any additional cost. Are these changes being requested because a wall is not going to happen and the grading will be an issue? Is the grading possible without an alignment change?

Scott,

Met with Edgar, Tom and Allen this afternoon and there are several questions on the proposed changes to the sidewalk:

- Everyone preferred the sidewalk to retain the original alignment on Hwy 22, but is ok with running it part way up 4th St. **So make the change or leave the alignment along Highway 22 the same?**
- Will all of the changes at the intersection meet ADA requirements? **Any changes would have to comply with ADA**
- What will be any additional cost and/or delay to the project? **If we make the change to the new plan there will be a little extra cost for the sidewalk to Slay from the new alignment. I estimate about 10 SY additional sidewalk with the new plan. The only delay will be getting the grades worked out and getting it restaked.**
- It appears that the original excavation for the project cut pretty deep into the hillside-could the tree possibly be saved if it hadn't been cut in so deep? **The cut is required due to ADA requirements. The only way to have saved the tree is to move the sidewalk closer to the highway like we are now considering. Likely some roots would have still been damaged even at the new alignment but it would have been less damage.**

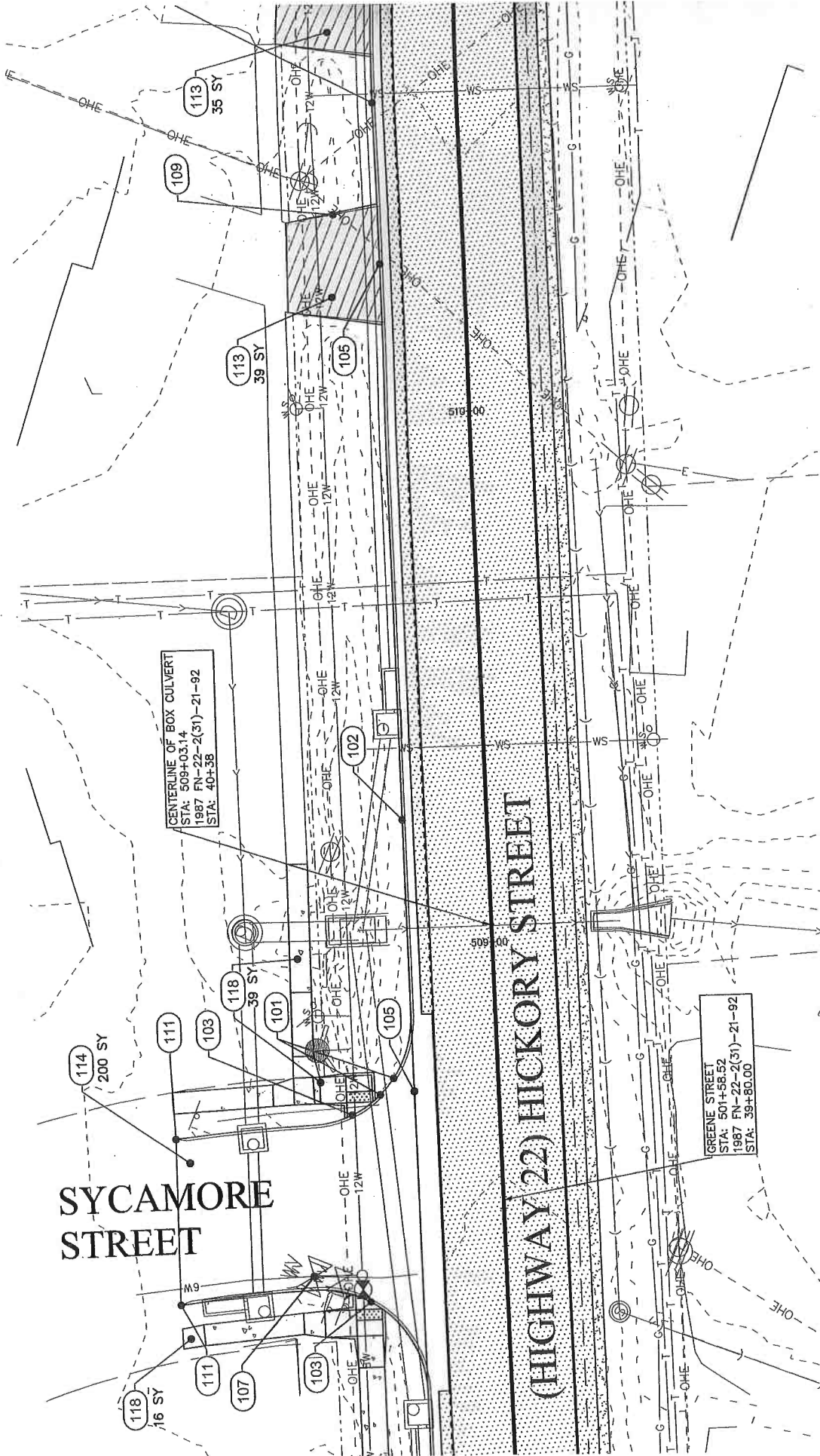

Subject: Sidewalk Between Sycamore and Schnoebelen

Right now the plans show replacing the westerly 40 feet of this sidewalk (the area of the bridge) with 4' wide sidewalk. There is an additional 288 feet to Schnoebelen. The cost to replace the remaining 288' at 4' wide is:

128 SY Sidewalk Removal \$8/SY - \$1,024.00
128 SY 4' Rock Base \$6/SY - \$768.00
128 SY 5" PCC Sidewalk \$39/SY - \$4,992.00
Total \$6,784.00

The cost to replace the whole length to 5' wide is as follows (would include replacement of curb ramp at Schnoebelen Street):

135 SY Sidewalk Removal \$8/SY - \$1,080.00
172 SY 4' Rock Base \$6/SY - \$1,032.00
172 SY 5" PCC Sidewalk \$39/SY - \$6,708.00
10 SF Detectable Warnings \$30/SF - \$300.00
Total \$9,120.00

The plans already show paving the two driveways between the sidewalk and the new curb and gutter.
