- Fire Department April 2022 Report (If you have any questions on the report, please contact Chief Smothers)
- New member of the Fire Department: Jonathon Ward, two new members to the cadet program: Isaac Thomann, Aaron Schaedler
- Murphy's is being leased by Wonder Women LLC, and they are applying for a Liquor License
- Casey's General Store #2629 is renewing their liquor license
- Elisa Lyons is applying for an Urban Chicken Application. Right now Riverside does not address this in the city code, however, this has been allowed previously.

5. Now is the time for the Public Hearing for the FY22 Budget Amendment. The Public Hearing Notice is on the website and was printed in the paper 5/11/2022.

6. Washington County Sheriff will provide overview of calls for service in Riverside.

7. This quote from Electric Pump is for a spare anti-scalant pump for the RO in the water plant. This pump protects the RO filters, and the plant will not run without a pump in place.

8. Trevor Sherping and Olivia Kahler, Kalona Library, would like to present the summer reading programs being offered for Riverside children this summer. They will be asking if there is funding available to help with this program. Trevor and I have also discussed the possibility of a book delivery/pick up program for those unable to get to the library. The options for this are Monday, Tuesday, and Friday 8:30-11:00, or Monday, Tuesday, Wednesday, and Thursday afternoon from 2:30-5:00 p.m.

9. Tony Boshart purchased the property on 191 E 1<sup>st</sup> St 2/15/2022. He has had very little usage until the bill between 3/15/2022-4/15/2022. Becky contacted him to inform him of his high usage. This is a rental unit, so he checked out the property and found a pipe that had broken in the basement and had a basement full of water. My question is I do not know where the water went, whether he has a floor drain or not. He will be at the meeting to discuss a partial sewer abatement for the sewer portion only. The unit is not occupied at this point. Average usage for the previous two months has been 15 gallons per month. Price for sewer is 100% of water, which is \$6.00/1,000 gallons.

The other variable is was there any water used for clean-up/repair on the property.

#### 11. Resolutions

- I have included the FY22 Budget Amendment that was in the paper, and the breakdown of what funds and line items were amended.
- Included is the proposed 28E agreement with the City of Kalona for a sharing agreement. This has been sent to the attorney for review, but I may not have the attorney reviewed copy until Monday.
- The counteroffer for the commercial lot has been accepted, not city council will need to set a public hearing for the sale of city owned real estate as required by law.
- This resolution formalizes the discussion with Lexy Walgren regarding payment of 50%, or NTE \$3,500 to tap the sewer main for 120 Cherry Lane. It was also mentioned that this agreement would also apply to Charlie and Mariellen Bower, Terry Stumpf and Mike Schneider, who own additional lots in developed areas that may or may not have a sewer tap off the main extended to their lot.
- I added the resolutions for change orders to the Railroad Park Project. The actual change order backup will be emailed separately as I won't receive those until Friday morning.

12. The city clerk will be providing and explaining the utility billing reconcile reports and provide an update of the building permits pulled this since the last meeting and the open permits to date.

13. I have included the administrator's report. If anyone has any questions, please do not hesitate to contact me.

- Monthly Financials-items to review:
  - General Fund ARPF funds-still need to find a use for the \$152,302.18 (2<sup>nd</sup> payment in August 2022)
  - Gaming, agreement funds, can be used for capital project
  - Hotel/Motel Tax 50 % has specific uses
  - Debt Service-final payment
  - Capital Projects-used for Railroad Park Project to date (\$242,550.93 will show up in May financials) plus the rest of the project should be paid by June 30<sup>th</sup>. Based on engineers estimates and engineering fees, should be approximately \$337,000 more from this fund.
  - Water-after the transfer to Capital Projects, currently not enough in the fund for monthly expenses and reserves. Still need to fund for the water plant repairs.
  - Sewer-Currently in pretty good shape. May need to transfer some of the funds for the 3<sup>rd</sup> Street Project. Also, not sure of the cost for the repairs to the wastewater plant.
- Amendments to City Code:
  - Chapter 20: This amendment would allow the City Administrator to discuss items of city business with the city attorney, and clarify that the city council as a body, not individually, could review items with the city attorney.

- Chapter 69: Add section 69.13, Recreational Vehicles Parking Limited to the parking regulations. This will clarify where vehicles can park and stored.
- Section 105.05 This is a beginning of the changes that Sheriff Schneider and I discussed. It is not in the complete form yet, just for your review to start thinking about.
- Section 106.10 This would add a section on how long carts can be at the curb as there are some that leave their carts at the curb continually.
- Section 165.11.a.2 Permitted uses in the M-1 Industrial District. This has been brought up before on where the city council would prefer the location for storage garages. Planning and Zoning recommended this change at their last Planning & Zoning meeting.
- Section 165.11.a.3 Remove living quarters in the M-1 zoning. Lois had brought this up at a city council meeting, and Planning & Zoning recommended this change at their last Planning & Zoning meeting
- Section 165.11.b.2 Permitted uses in M-2 District. This change would allow storage garages in the M-2 District. This was recommended for change at the last Planning & Zoning meeting.
- Section 165.21.3.A.2 This will add the wording clarification from the recommendation from Planning & Zoning.
- I also included a sample of an urban chicken ordinance and Chapter 75 that Tom had asked to be reviewed at a later date.
- I have included the last list of short/long-term goals that have been discussed.

RIVERSIDE CITY COUNCIL MEETING: Monday, May 5th, 2022

The Riverside City Council meeting opened at 6:00 pm at City Hall with Mayor Allen Schneider requesting roll call. Council members present: Tom Sexton, Edgar McGuire, Lois Schneider, Kevin Kiene, and Kevin Mills.

Motion by Kiene to approve agenda, moving #11 I to after #7. Second by Schneider, passed 5-0.

Kiene moved to approve the minutes of April 18th, expenditures, and Liquor License renewal for Kum & Go. Second by McGuire, passed 5-0.

Kathhy Lindhorst asked about the progress on Community Center.

Sandie Ubben reported on City Wide Garage Sales on May 6<sup>th</sup> and 7<sup>th</sup>.

Damon John of Riverside Casino and Golf Resort gave an overview of the casino events and trends.

Mary Audia of WEDG reported on economic activities in the county.

Rusty Rogerson requested for two blocks of Greene Street to be closed for Show and Shine car show on July 10, 2022 from 9 am to 4 pm. Mills moved to approve street closing request for car show. Second by Schneider, passed 5-0.

Mary Beth Rozmus addressed Council on water and sewer connections for lot owned by Zach and Lexi Walgren on 120 Cherry Lane. Mills moved to pay 50% of sewer installation up to \$3500. Second by Sexton, passed 4-1, McGuire opposed.

Brian Boelk, Axiom Consultants gave updates on Railroad Park, East Street extension, Wastewater plant repairs, and Water Plant piping repairs.

Kiene moved to proceed with schematics and estimate of extension of East Street. Second by Schneider, passed 5-0.

Schneider moved to approve Axiom quote for forensic investigation of issues at the Wastewater Plant. Second by McGuire, passed 5-0.

Admin Yancey review Arborist Dahl report on tree at north end of East Street. Kiene moved to have Admin send letter to homeowners. Second by McGuire, passed 5-0.

Kiene moved to pass Resolution #2022-53, Approving City Council Rules. Second by Sexton, passed 5-0.

Sexton moved to pass Resolution #2022-54, Approving update City Clerk and City Administrator job descriptions. Second by McGuire, passed 5-0.

Kiene moved to pass Resolution #2022-55, Approving resolution to publish, and set the date of FY21-22 Budget Amendment for May 16<sup>th</sup> at regular City Council Meeting starting at 6 pm. Second by McGuire, passed 5-0.

McGuire moved to pass Resolution #2022-56, Approving pay request #1 to All American Concrete for Railroad Park Project in the amount of \$242,550.93. Second by Sexton, passed 5-0.

Schneider moved to pass Resolution #2022-57, Approving SHARP copier lease with Access Systems. Second by McGuire, passed 5-0.

Yancey presented Administrator's report, update on Board of Adjustments meeting, and Planning & Zoning minutes of April 26, 2022.

Admin received estimate on City Hall exterior repairs. Mills moved to proceed with specs and plans for bidding. Second by McGuire passed 5-0.

Admin presented proposal from Kalona for shared 70/30% split cost for a Building Inspector. Sexton moved to proceed with 28E agreement for Building Inspector at 30% cost of \$22,130.01 for the first year. Second by McGuire, passed 5-0.

Council reviewed proposed renewal agreement with Riverside Casino and Golf Resort.

McGuire moved to accept proposed fees for a full Audit Service from Gronewold, Bell, Kyhnn & Co. Second by Sexton, passed 5-0

Admin gave update on spam emails.

Sexton moved to adjourn at 9:42 p.m. Second by McGuire, passed 5-0.

## April 2022 Update

### **Calls for Service:**

### **Training:**

The RFD held a joint training with our mutual aid FD's on 4/2 for 8 hours. The training covered fire ground operations on hose line management, stretching, advancing, fire attack, forcible entry and search and rescue under live fire conditions. This 8 hour training was held at the RFD training facility. This type of training is valuable to how we all work together and operate at structure fires. The FD's attending that day were Riverside, Ainsworth, Hills, Lone Tree and Wellman. (Kalona had pancake breakfast that day so unable to attend)

### **RESA:**

The breakfast was supported great by the community, we served over 1200 people which is a record for us, previous high was 1000. We raised around \$16,000 which will go towards future equipment purchases.

### **Other News**

The storm siren is operational after working with Graybill and RACOM it was discovered after more testing the issue was with the antenna at Washington County Dispatch. This is not a 100% perfect option/fix as we're still dealing with old outdated communications equipment to operate the storm sirens. This is a county wide problem, Toby and Christine had several meetings and more time invested into figuring out how to get the sirens working again. Thanks to Toby for his hard work on making sure our community safe. The new brush truck is still at Feld Fire for installs, they're still waiting on a couple pieces to finish.

I would ask that if anyone ever has questions to reach out to the command staff and ask them, prior to making decisions or statements about RFD.

- Brent Briley with Subsurface Solutions and spent a day with Benjamin training him on the finer points of using our locator.
- RO Train #3 motor was reinstalled but, on start-up, it blew a seal out the top. We purchased replacement seals. We hope there isn't any damage to the pump that caused this but we will find out after we replace the seal and try again. We decided to get a quote for a new pump just in case. Either way, given the supply chain issues, we recommend having another pump as a back up.
- The Anti-Scalent pump was giving us issues with priming and sending a "pump" signal to the PLC. The plant will not run without this signal, so it is a very critical piece of equipment. We discovered we only have one of these pumps, but the skid requires 2. we intend to purchase one pump to install and order a second one in the next budget year as a spare. |
- We met with V&K on May 2 to discuss plans to replace the schedule 80 piping in the water plant. We've had 7-8 distinct breaks in the past month so we are very eager to get this piping replaced with a more practical, stronger, material.
- A large portion of the month we spent developing SOPs for the water treatment with an emphasis on RO operations.
- We put on a curb stop riser on a service on Kleopfer Ave.
- On May 9<sup>th</sup> we tapped the water main for service at 120 Cherry Lane and mapped it.
- In April, we posted 4 disconnect notices and shut 1 customer.

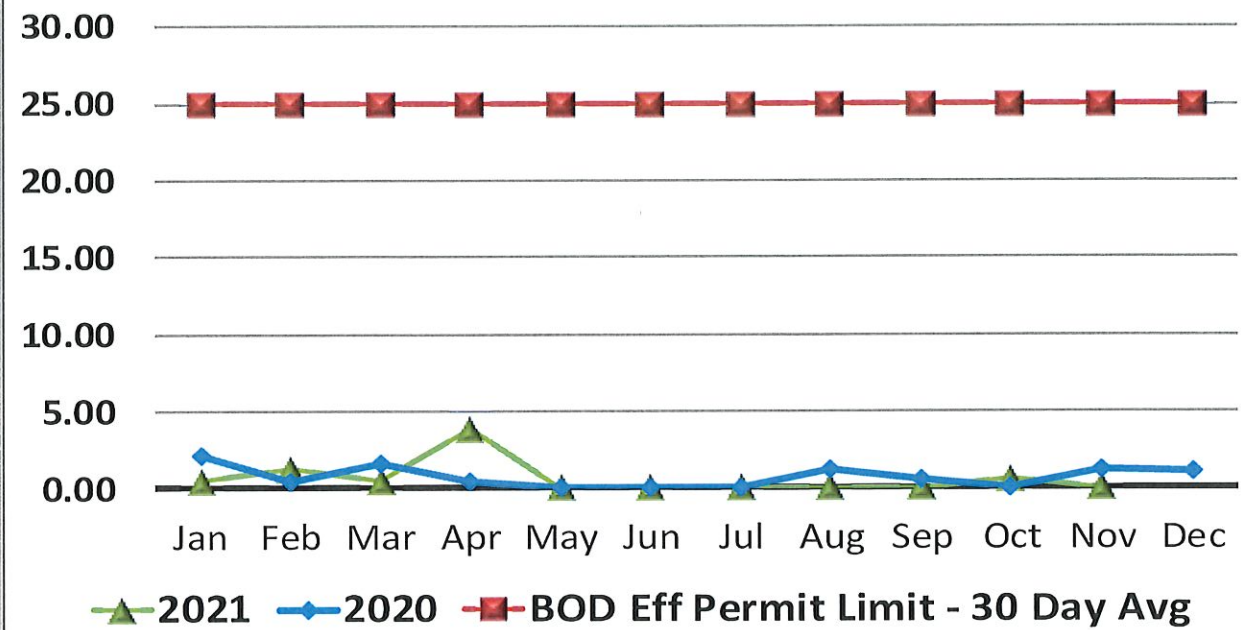
- We will be E.coli testing in May
- Effluent ammonia was a little high in the first week of April. We think this may have been caused by "bug" inactivity from the winter. We increased our solids and, with the warmer temperatures, we were able to get it back down to zero.
- We discovered the air compressor on the UV system was inoperable, so we ordered a replacement. This compressor powers the cleaning system for the UV system so we are looking forward to getting that going again.
- The sewer main in the 3<sup>rd</sup> street project was televised and the report was given to the city.

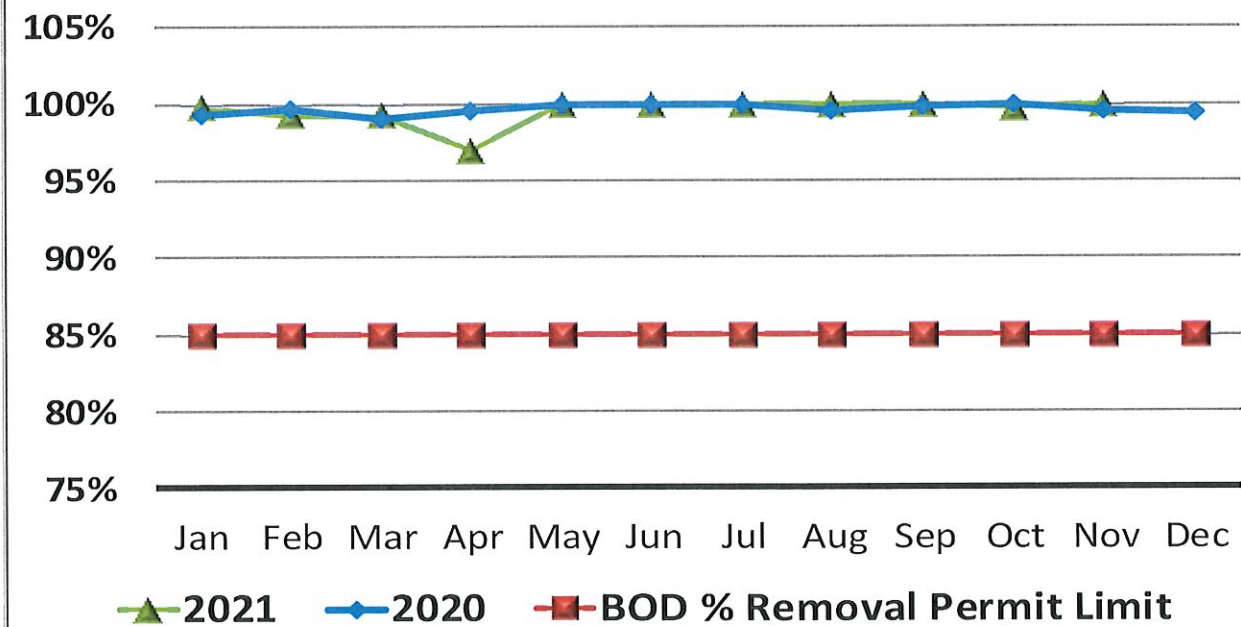

### BOD Effluent

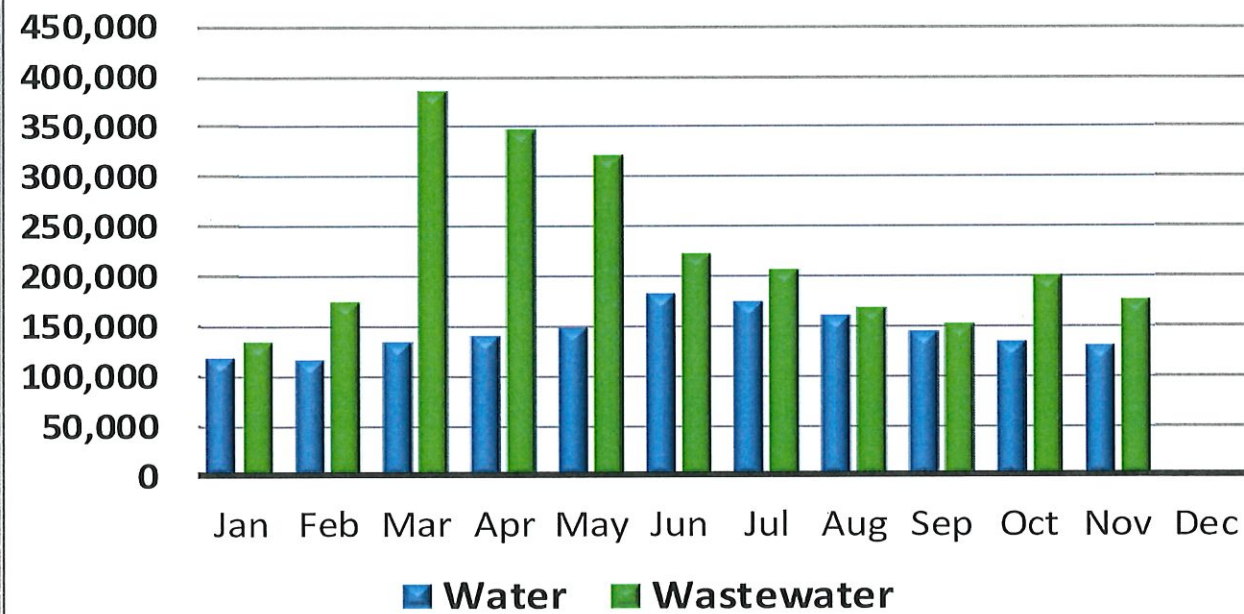


### BOD % Removal

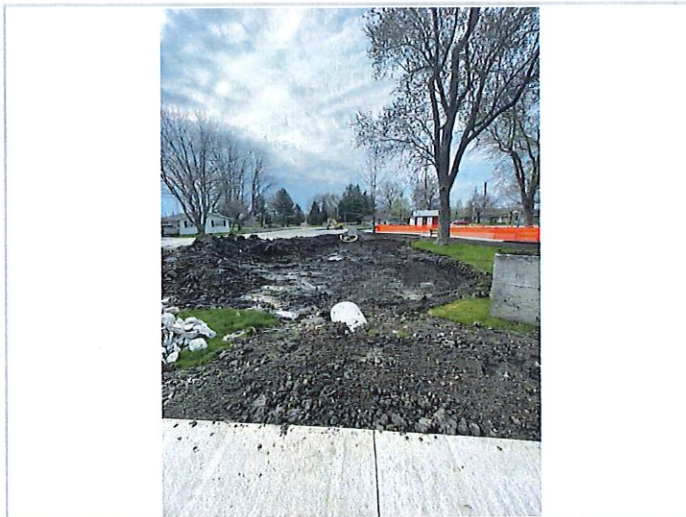

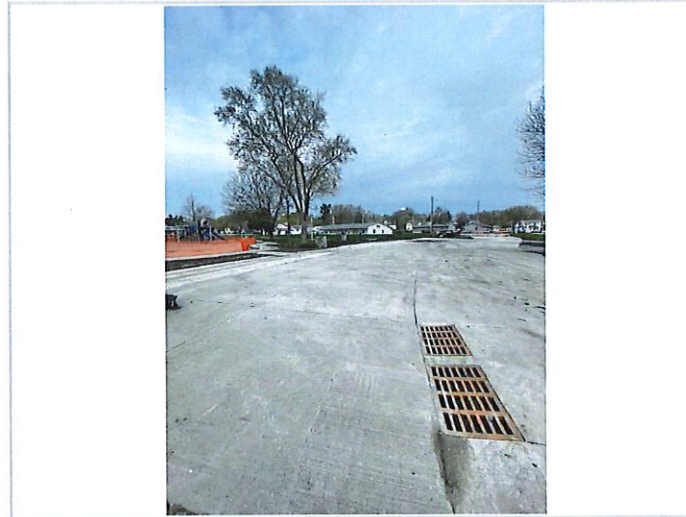

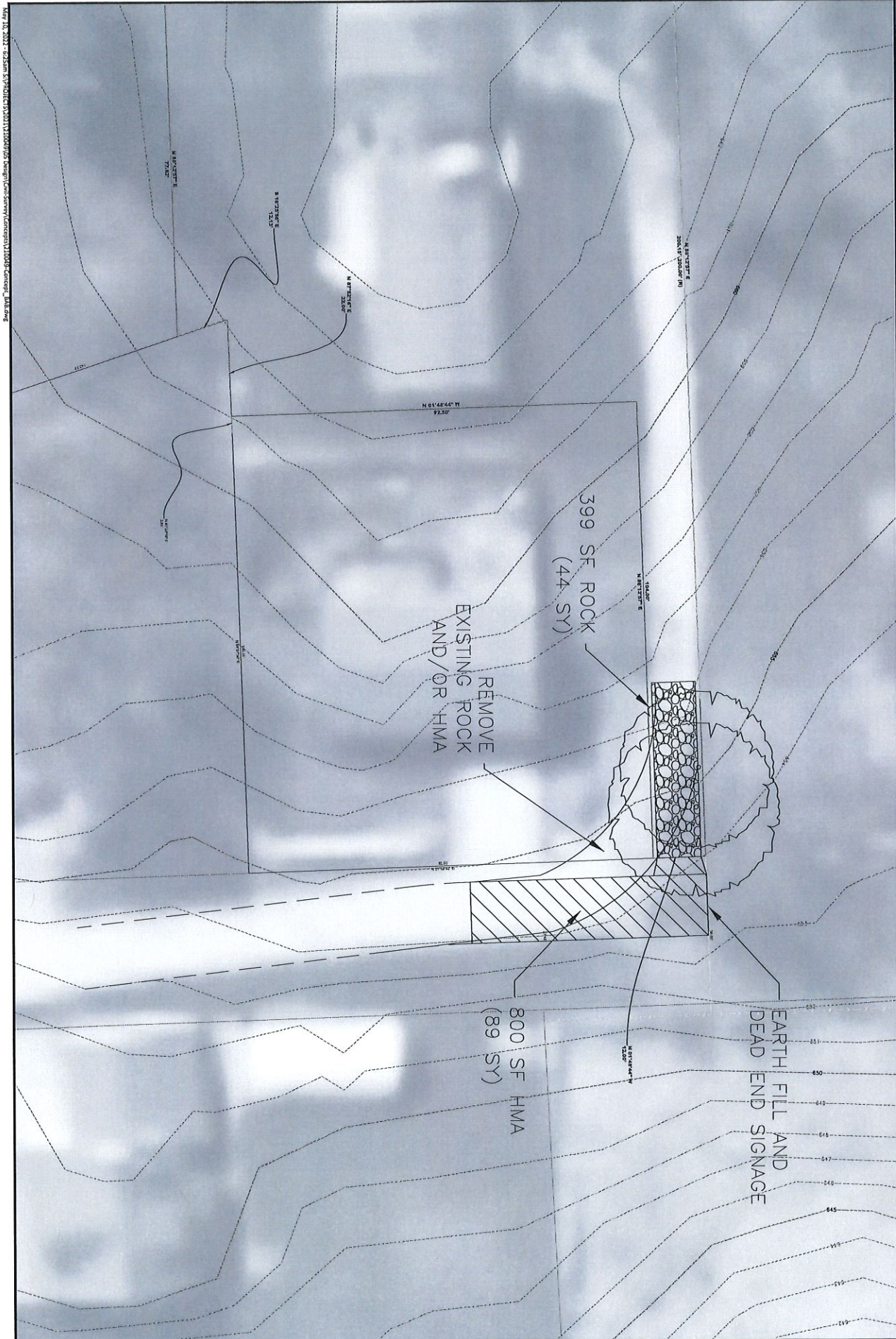

## 28E AGREEMENT

This Agreement is entered into the date last executed by the parties, by and between the City of Kalona (hereinafter referred to as "City") and the City of Riverside, Iowa (hereinafter referred to as "Riverside") pursuant to Iowa Code Chapter 28E providing for cooperation between governmental agencies.

**WHEREAS**, the city has from time to time requires inspection staff to inspect buildings and manage building permits within the City of Riverside; and,

**WHEREAS**, the city has from time to time requires inspection staff to manage nuisance abatement within the City of Riverside; and,

**WHEREAS**, the city has from time to time requires inspection staff to provide rental inspections services within the City of Riverside; and,

**WHEREAS**, the city has from time to time requires inspection staff to assess code compliance within the City of Riverside; and,

**WHEREAS**, the Parties have determined that it is in the best interest of the City to enter into an Agreement with Riverside to allow for City inspection staff to work for Riverside.

Now, therefore, the parties hereby agree as follows:

- **28E Agreement.** This Agreement is entered into pursuant to the provisions of Chapter 28E, Code of Iowa (2001). This Agreement shall const of 3 pages.
- **No Entity.** No separate, legal or administrative entity is created by this Agreement. No real or personal property will be purchased in the performance of this Agreement.
- **Administrators.** The City Administrator, or his or her designee, and the Riverside City Administrator, or his or her designee, shall administer the performance of this Agreement.
- **Term.** The term of this Agreement shall be for the date of execution of this contract for a term of 5 years or until the date terminated under provisions of this Agreement. This Agreement may also be terminated upon the default of a party. If a party should fail to perform any covenant, agreement, or obligation under this Agreement, the other party may terminate the Agreement upon ninety days written notice, which notice shall specify the default claimed; provided, however, that the defaulting party shall be entitled, within such ninety-day period, to reinstate the Agreement by curing or remedying any such default to the other party's reasonable satisfaction. Notice shall be sent to the governing body of the other party at its principal place of doing business by registered mail. The



termination of this Agreement shall not relieve any party to this Agreement of any obligation or liability arising during the term of this Agreement.

In the event of a breach by Riverside or the City of this Agreement, that breach shall not be considered to affect any remaining terms or conditions of this Agreement. If any terms or conditions of this Agreement are held to be invalid or illegal, those remaining terms or conditions shall not be construed to be affected.

At the end of the Initial Term, this Lease will renew for additional five (5) year basis, unless and until terminated by one party upon six (6) months prior written notice to the other party, or as otherwise provided. In this Agreement.

- **Consolidation.** The City and Riverside agree that the City will, effective on or before June \_\_\_, 2022, allow its Building Inspector to work for Riverside at an annual negotiated percentage of total employee cost to include all benefits afforded to a City employee per their personnel manual. The City shall always allow any of the City's equipment used by the Building Inspector in his or her employment with the City to be used by the Building Inspector when working in Riverside. There will be negotiated monetary payment from Riverside to the City for the use of their equipment and for vehicle fuel. This negotiated rate will be evaluated every 6 months for miles used and fuel price trends. (ADDENDUM A)
- **Compensation.** Riverside agrees to re City shall be compensated at a rate of 30% for normal cost of an employee, but not limited to, Federal and State income tax withholding, Social Security, Medicare, IPERS and Workmen's Compensation (ADDENDUM B)
  - Riverside agrees to indemnify from and against all liability or loss the City may sustain as a result of claims, demands, costs, or judgments arising from utilization by Riverside of the Building Inspector. Further, Riverside hereby agrees to indemnify an hold harmless the City, its agents, assign and successors in interest from and against any and all loss, expense, including legal fees and disbursements, damage or injury growing out of, resulting there from, or arising from utilization by the City of the Building Inspector.
  - The City will cover all upfront cost for equipment, software and travel for certification conferences. Riverside agrees to compensate the City at a rate of 30% for all cost associated with maintaining an inspector.
  - The City will cover all computer equipment cost. Riverside agrees to compensate the City at a rate of 30% for all computer related cost. Should the agreement be terminated, the City would reimburse Riverside for any computer newer than 4-years at a depreciated rate of 25% yearly.

- The City will invoice Riverside prior to the 10<sup>th</sup> of each month for the previous months expenditures. Invoice would be payable to the City no later than the 10<sup>th</sup> of the following month.

- **Execution of Agreement.** The parties shall approve the Agreement by resolution or motion of the respective board or council, which shall authorize the execution of the Agreement. It will then be filed in the office of the Iowa Secretary of State and the Recorders of Washington County, in accordance with Chapter 28E of the Code of Iowa. The Agreement shall become effective when recorded in the Secretary of State's Office and shall remain in effect unless terminated as provided herein. This is the entire Agreement between the parties, and it may be amended only upon the Agreement of both parties and only in writing. The laws of the State of Iowa apply to this Agreement.

**In Witness whereof,** Riverside and City have caused this Agreement to be executed in four separate counterparts, each of which shall be considered an original.

**CHAPTER 4-3 DOMESTIC FOWL ORDINANCE**

Approved 7-7-2020

**4-3-1 DOMESTIC FOWL:** The only domesticated fowl allowed in the City of Lime Springs are Chickens, Geese and Ducks.

**4-3-2 PERMIT REQUIRED:** No person shall raise, harbor, or keep chickens, geese or ducks without a valid permit obtained from the City Clerk.

**4-3-3 FEES:** Annual fee is \$ 5.00 per Bird, not to exceed \$ 25.00 per residence. Fees are billed annually with the June City Bills. Late Fees of \$ 2.00 per month will be charged after August 25<sup>th</sup>.

**4-3-4 NUMBER and TYPE FOWL ALLOWED:** The maximum number of birds allowed is no more than 6 at one time on the property. Only female birds are allowed. No roosters are allowed.

**4-3-5 ENCLOSURES:** All birds must always be kept in an enclosed or fenced area. Enclosures must be kept clean, odor-free, neat, and sanitary at all times. Enclosures must provide adequate ventilation and adequate sun and shade and must be impermeable to rodents, wild birds, and predators, including cats and dogs. Birds must be secured within a henhouse or coop during non-daylight hours. The enclosure may be mobile. Hen houses and pens shall be well maintained. All enclosed pens shall consist of sturdy fencing.

**4-3-6 ODOR and NOISE IMPACTS:** Odors from birds, manure and or other bird-related substances shall not be perceptible beyond the boundaries of the permitted property. Noise from the birds shall not be loud enough beyond the property boundaries to be loud enough to disturb persons of reasonable sensitivity.

**4-3-7 FEED and WATER:** Birds shall always be provided with access to feed and clean water. The feed and water shall be unavailable to rodents, wild birds, and predators. The bird owner shall take necessary action to reduce the attraction of predators and potential infestation of insects and parasites. Birds found to be infested with insects and parasites that may result in unhealthy conditions to human habitation may be removed by city employees or law enforcement.

**4-3-8 WASTE STORAGE and REMOVAL:** All stored manure shall be covered by a fully enclosed structure with a roof or lid over the entire structure. No more than 3 cubic feet of manure shall be stored on the property. All other manure not used for composting or fertilizing shall be kept free from trash and

accumulated droppings. The manure can be disposed at the City Dump on the Brush Pile, NOT the Compost Pile.

**4-3-9 BIRDS AT LARGE:** The bird owner shall not allow the birds to roam off the permitted property. No dog or cat or other domesticated animal which kills a bird off the permitted property will be considered, for that reason alone, a dangerous or aggressive animal nor is the City's responsibility to enforce the animal control provisions.

**4-3-10 NUIANCES:** Any violation of the terms of this chapter which constitutes a health hazard or interferes with the use or enjoyment of the neighboring property is considered a nuisance and may be abated under the general provisions by the City Ordinances.
